

## Gold Strengthens as Uncertainty Around the Fate of U.S. Healthcare Bill Remains

Earlier this week, there was underlying uncertainty and cautious tones surrounding U.S. healthcare plans as an unsettled U.S. dollar coincided with the rising price of gold. With gold prices reaching the strongest level in the past 3 weeks, markets looked ahead to a key health care vote in Congress expected on Thursday afternoon. However, after a failed lengthy attempt to win needed support for their Obamacare repeal-and-replacement bill, House leaders postponed the long-awaited vote, followed again by another postponement on Friday afternoon. As the U.S. dollar experienced instability earlier on in the week, both silver and gold experienced heightened gains, with the price of gold increasing rapidly before settling at US\$1,248 per ounce on Friday. Global markets in general were down; the S&P/TSX Composite Index fell almost 48 points to close at 15,443, while the Dow Jones Industrial Average closed down 313 points at 20,597. The S&P/TSX Global Gold Index settled at 211 on Friday. It was a mixed week for precious and base metals; silver (up 1.93%), palladium (up 3.99%), and lead (up 2.60%) all followed the gold price to finish the week at US\$17.75, US\$809, and US\$1.06 respectively. Meanwhile, platinum (down 0.13%), copper (down 2.41%), nickel (down 4.03%), and zinc (down 1.86%) all fell, to finish the week at US\$964, US\$2.62, US\$4.45, and US\$1.28 respectively. WTI crude fell 2.35% finishing at US\$48 per barrel.

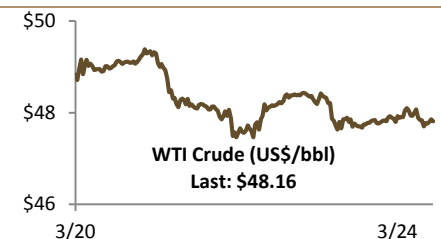
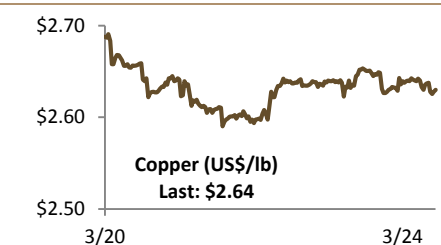
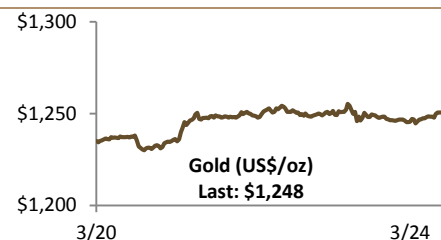

### Macroeconomic News

#### United States

MBA mortgage applications fell 2.7% in the week ended March 17, following a 3.1% increase the prior week. Refinancing applications also decreased, falling 3.3%, and applications to purchase a home decreased 2.1%. However, average fixed 30-year mortgage rates were unchanged at 4.46%, the highest since April 2014. In February, existing home sales fell 3.7% compared with January's sales, to reach a seasonally adjusted annual rate of 5.480 million. Falling short of market expectations, sales were still 5.4% higher compared with a year ago. However, the supply of existing homes has tightened. While the number of homes on the market increased 4.2% last month, housing inventory remained close to the all-time low of 1.65 million units hit in December. Inventory was 6.4% lower than it was a year ago, and the median home price rose 7.7% compared with February 2016, to reach \$228,400. Meanwhile, new home sales for the month of February increased to a 7-month high, rising 6.1% to an annualized pace of 592,000. The pickup in demand last month was led by a 30.9% jump in the Midwest that had an annualized rate of sales in the region at 89,000 in February, the strongest pace since November 2007. There were 266,000 new houses on the market at the end of February, and the median sales price of a new house dropped 4.9% from February 2016 to \$296,200. Initial Jobless claims for the week ending March 18 exceeded market expectations of 240,000, rising 15,000 to reach 258,000. The previous week's level was revised upward by 2,000 to 243,000. The 4-week moving average was revised upward by 1,750 to 239,000. Continuing jobless claims, meanwhile, fell 39,000 to 2 million in the week ended March 11. These claims, reported with a 1-week delay, reflect the number of people already collecting unemployment cheques. Orders for durable goods rose 1.7% in February, exceeding market expectations after an upwardly revised 2.3% increase in January. Orders for commercial aircraft increased by 47.6% in February and were the main driver of the increase. Non-defense capital goods orders excluding aircraft, a closely proxy for business spending plans, fell 0.1 % after a 0.1% rise the previous month. Orders so far this year are running 1.6% higher than in the first two months of 2016. The Markit flash US manufacturing PMI fell to its lowest rate in the past 5 months as it reached 53.4 in March from 54.2 in February. This drop was well below expectations of 54.8, and is mainly due to a slowdown in new orders and lower stocks while input cost inflation picked up. Preproduction stocks were accumulated at the weakest pace since last September, while finished goods inventories dropped for the first time in six months.

#### Canada

The NSA consumer price index (CPI) in Canada increased by 0.2% from January's 129.5 to reach a high of 129.7 Index Points in February. On a year of year basis, the consumer price index rose 2.0% in February. The move compared with a 2.1% increase in January. However, excluding gasoline, the CPI was up 1.3% year over year in February, following a 1.5% increase in January. According to Statistics Canada, the main contributors to the 12 month change in the CPI were the transportation and shelter indexes, whereas the food index decreased for a fifth consecutive month.

#### **Plateau Uranium Inc. (PLU-V, \$0.60, not rated) – Encouraging Grades Intersected at Pinocho Target Highlight Potential of Zone**

Plateau Uranium has released results of six new holes drilled from two platforms at the Pinocho target at its Macusani Plateau uranium project, Peru, which hosts an all-categories National Instrument 43-101 uranium resource of 124 million pounds (Mlb) of U<sub>3</sub>O<sub>8</sub> (225 million tonnes [Mt] grading 250 parts per million [ppm] U<sub>3</sub>O<sub>8</sub>), and a lithium resource of 175,740 tonnes of lithium oxide (Li<sub>2</sub>O) equivalent (140 Mt grading 0.126% Li<sub>2</sub>O equivalent, Indicated plus inferred).

#### **Select Drilling Highlights**

- TNE (70° @ 65° azimuth) – Intersected 8.0 metres grading 861 ppm U<sub>3</sub>O<sub>8</sub> from 53 metres depth, including 3.0 metres grading 2,160 ppm, and 3.5 metres grading 162 ppm U<sub>3</sub>O<sub>8</sub> from 66.5 metres depth. Also, intersecting 20.0 metres grading 1,154 ppm Li<sub>2</sub>O, from 50 metres depth.
- TNW (70° @ 355° azimuth) – Intersected 9.0 metres grading 566 ppm U<sub>3</sub>O<sub>8</sub> from 53 metres depth, including 2.0 metres grading 2,182 ppm, and 8.0 metres grading 148 ppm U<sub>3</sub>O<sub>8</sub> from 88.0 metres depth. Also, intersecting 12.0 metres grading 1,177 ppm Li<sub>2</sub>O, from 50 metres depth, and 20.0 metres grading 1,259 ppm Li<sub>2</sub>O, from 160 metres.

This week, Cardinal Resources Limited (CDV-ASX) reported its second interim metallurgical update for its Namdini project. Highlights include the findings that a number of conventional gold recovery-improvement techniques are showing overall gold recoveries of 84% are easily achievable, and that a conventional crush-float, fine-grind carbon in leach (CIL) flowsheet continues to be the preferred processing option. The conventional crush-float, fine-grind CIL flowsheet allows for a low-mass flotation concentrate having superior



operating costs owing to low volumes of high-grade concentrate to be processed. This encouraging baseline result leads into the next phase of test work that will target a significantly higher improvement in overall recovery. In the announcement earlier this week, Cardinal Project Manager Bruce Lilford stated that “Independent Metallurgical Operations (IMO) in conjunction with Oreway Mineral Consultants (OMC—a subsidiary of Lycopodium) from Perth, Australia have recently been contracted to develop a metallurgical programme which is representative of the entire Namdini deposit. The resulting report from this new programme is due during Q3 2017 and will be of a level sufficient to complete a feasibility study.”

Osisko Mining announced additional drill results from its ongoing 400,000 metre drill program at its 100% owned Windfall Lake gold project located in Urban Township, Québec. The program combines definition drilling above the Red Dog intrusion, expansion drilling above and below Red Dog, expansion drilling to the NE of the main deposit, and exploration drilling on the greater deposit and Urban-Barry Project area. The current drilling results released consists of 8 drill holes and are focused on infill and expansion drilling in the Caribou Corridor. Please see below for highlights and Table 1 for full results.

#### **Drilling Highlights:**

- Drill Hole OSK-W-17-766-W1: 5.8 metres grading 15.6 g/t gold from a downhole depth of 675 metres, including 3 metres grading 27.6 g/t gold.
- Drill Hole OSK-W-17-778: 3.5 metres grading 15.0 g/t gold from a downhole depth of 643 metres, including 1 metres grading 48.7 g/t gold.
- Drill Hole OSK-W-17-787: 6.5 metres grading 7.21 g/t gold from a downhole depth of 508 metres, including 1 metre grading 24.1 g/t gold.

As the Company continues to build towards its updated resource estimate, it has used its additional rigs on site to further test the expansion potential both above and below the Red Dog intrusion and to the north east of the main deposit. Drill hole OSK-W-17-766-W1 intersected a new mineralized zone discovered in the main Caribou Corridor. This new zone, located 40 metres in the footwall of the CS1 Zone, consists of 2% to 15% pyrite stringers with several specks of visible gold. This zone was cross-cut at depth by Red Dog. OSK-W-17-781 extended the CS1 zone down-plunge by 120 metres with 3.05 g/t Au over 2.5 metres in a bleached andesite containing 5-10% pyrite stringers. Meanwhile, OSK-W-17-777 extended the CS3 zone by 16 metres in its down-dip extension with 9.01 g/t gold over 4.0 metres. In addition, drill hole OSK-W-17-786 tested the continuity of the CS3 zone and extended the zone by another 35 metres in its down-plunge extension with 6.64 g/t gold over 4.9 metres. This intercept is located 30 metres down-plunge of OSK-W-17-777 described above. Finally, drill hole OSK-W-17-787, appears to have assisted in confirming the Caribou Extension as it intersected high grade gold mineralization on the 500 metre step-out section testing the ENE extension of the Caribou Corridor.

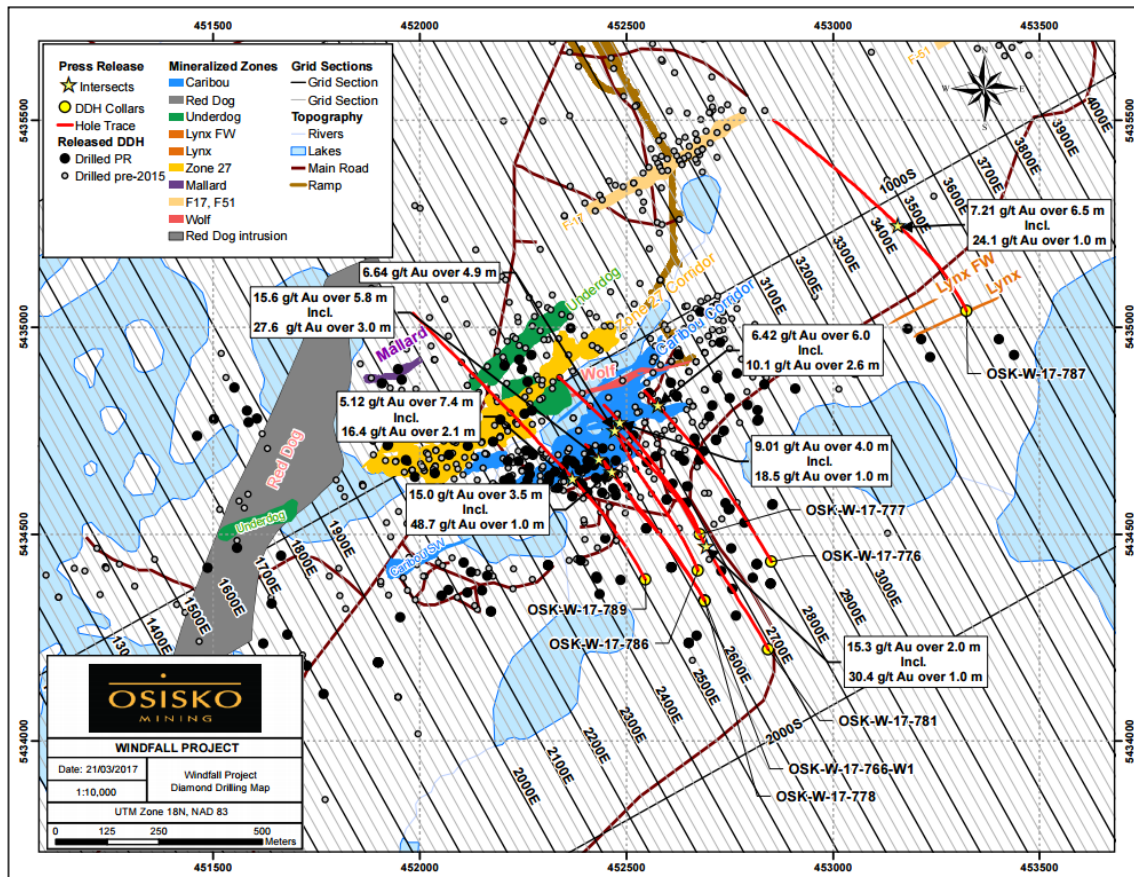

On Friday, Orex Minerals Inc. (REX-V) announced that its project partner Fresnillo PLC (LSE:FRES, not rated) completed a Phase-V exploration diamond drilling program of 11 holes on the Coneto Gold-Silver Project in Durango, Mexico. The Project is a joint venture in which Fresnillo has 55% ownership, and Orex the remaining 45%. The Phase-V drilling program tested a variety of targets across the Coneto property. In total, there were 5,215 metres in 11 holes. Three holes were drilled in the Northern Zone (La Bufa, Santo Niño), three holes in the Western Zone (Loma Verde), four holes in the Southern Zone (Durazno, Nogales, Promontorio), and one hole in the Central Zone (Descubridora). Of the recent drilling results, the thickest intercepts were in the Durazno Vein, although the grades were not particularly high in the areas tested, it did indicate that the structures continue at depth. A Durazno intercept of 44.75 metres core length yielded 0.42 g/t gold and 2 g/t silver for a silver-equivalent of 30 g/t (please note that the silver-equivalent is based on a gold price of \$US



1,200/oz and silver price of \$18/oz, for an Au:Ag ratio of 66.67:1 and that recovery is assumed to be at 100% for the purpose of the silver-equivalent). In addition, there appears to be a gold-rich vein in the hanging wall of Durazno, where drill hole BCO-80 yielded 1.30 metres core length grading 4.71 g/t gold and 4 g/t silver for a silver-equivalent of 318 g/t. Drill hole BCO-78, a hanging wall structure east of Loma Verde, yielded 9.05 metres core length grading 0.34 g/t gold and 9 g/t silver for a silver-equivalent of 32 g/t, including 1.60 metres grading 1.50 g/t gold and 28 g/t silver for a silver-equivalent of 128 g/t. The lone hole in Descubridora Vein, drill hole BCO-83, intercepted 7.70 metres core length grading 0.42 g/t gold and 27 g/t silver for a silver-equivalent of 55 g/t, including 1.45 metres core length grading 1.01 g/t gold and 67 g/t silver for a silver-equivalent of 134 g/t. Another highlighted intercept was in the Nogales Vein, east of Durazno-Impulsora, where drill hole BCO-82 intercepted 1.25 metres core length grading 0.40 g/t gold and 402 g/t silver for a silver-equivalent of 428 g/t. ### Radar Flashes

#### **Integra Gold Corp. (ICG-V, \$0.78), [Buy Rating, \$0.90 Target Price]] – Indicated Resource Doubles, Plus a Slight Grade Increase at Triangle**

This week, Integra announced an updated resource estimate on the Triangle deposit at its 100% owned Lamaque Gold Project in Val-d'Or Quebec. The update is as of January 11, 2017, and includes an additional 117,734 metres of new drilling at Triangle since the last resource update (November 2016), with ~75% of that drilling being infill. Triangle is the main resource area at Lamaque, accounting for ~75% of the overall resource at Lamaque currently.

- **Triangle Indicated Resources Now 1.47 Million Ounces** – At a 3.0 grams per tonne (g/t) gold cutoff, indicated resources increased ~100% to 1.47 million ounces (Moz), from 0.74 Moz, and the average grade increased by 4.4% to 7.32 g/t gold. At a 5.0 g/t gold cutoff, indicated resources increased 105% to 1.19 Moz (from 0.58 Moz), and the average grade increased by 3.1% to 9.24 g/t gold.
- **A Solid Mine Life and Lots of Resource Upside** – In the recently released updated February 2017 Preliminary Economic Assessment (PEA), in total 1.40 Moz are mined over a 10-year mine life from the Triangle, No. 4 Plug, and Parallel deposits, with Triangle making up 1.1 Moz, or 78%. We continue to believe that there is potential for increased mine life at Lamaque, and our current valuation includes 1.5 Moz mined over 10 years.
- **2017 Program Should Be ~100,000 Metres of Drilling** – Integra is planning about \$10 million of drilling this year in addition to the ramp development and bulk sample at Triangle, which is currently underway. An additional 15,021 metres in 75 drill holes have been completed at Triangle since the cutoff date for Wednesday's resource update, and overall, Integra has drilled 22,884 metres in 102 holes so far this year. A Sigma resource update is also currently underway and will be completed in Q2/17, based on relogging and reinterpreting the old database.

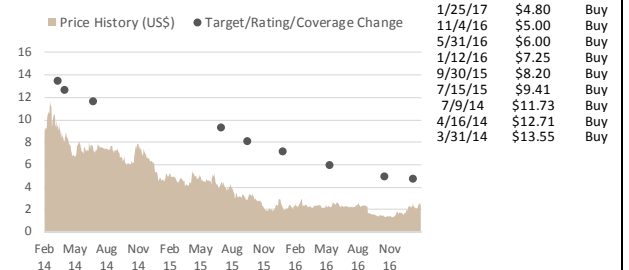
## Price Chart, Rating and Target Price History (as of March 24, 2017)



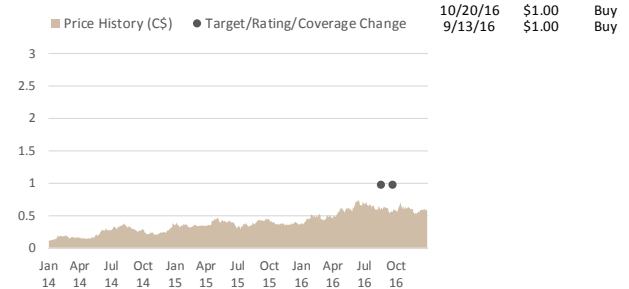
